(4) The Registration return proformae (in one lot) duly typed in double space and complete in all respects should be sent to this office alongwith original documents wherever required, upto **November 18, 2020** of the year of admission positively. After that Regd. returns/documents will be accepted by the office with the prescribed late fee, failing which the names of defaulting students be struck off from the college/Deptt. rolls with intimation to this office.
